

The aim of this Course is to provide an overall review of topics that would be of interest and relevance to family physicians in both rural and urban practice. Methods:

The workshops will allow for informal discussion and consultation with faculty. The David J.G. Tector Memorial Lecture will present an in-depth examination of an academic topic in Medicine. The faculty includes both family physicians and specialists affiliated with McGill University, as well as invited speakers.



STEVEN A. GROVER MD, MPA, FRCPC

BIOGRAPHICAL SKETCH:

Dr. Steven A. Grover is the founding director of the McGill Cardiovascular Improvement Program (CHIP) and the Center for the Analysis of Cost-Effective Care at the McGill University Health Center. Dr. Grover served as the Director of the Division of Clinical Epidemiology at the Montreal General Hospital from 1994-2006. Dr. Grover is also a Professor in the Departments of Medicine at McGill University. Dr. Grover was a Professor of Epidemiology and Biostatistics at McGill University from 1998 to 2009. After graduating with a medical degree from McGill University, he completed his post-graduate education at the University of California at Los Angeles (UCLA), McGill University, and Harvard Medical School. He then received his research training at the Brigham & Women's Hospital while completing a Master's of Public Administration at the Kennedy School of Government, Harvard University.

RESEARCH INTERESTS:

Dr. Grover's major research interest is the development and validation of computer simulation models to forecast the progression of cardiovascular disease, diabetes, and cancer. These models are used for assessing the risk and benefits of different risk factor screening strategies or therapeutic interventions. His research group has also recently completed a detailed economic analysis of cardiovascular disease which allows for cost-effectiveness analyses of risk factor reduction interventions. This work has been recognized internationally and, in 1991, Dr. Grover was awarded the Henry J. Christian Award for excellence in research at the national meeting of the American Federation for Clinical Research.

Other research interests include quality of life assessment and the economic analyses of cardiovascular disease, diabetes, obesity, HIV disease, prostate cancer and other diseases impacting on the health of men and women. He received the Prix IMS Health Canada for outstanding health economics research in 2000. Erectile dysfunction is a focus of more recent research and Dr. Grover received the Yamanouchi Impotence Best Abstract Series Award at the annual meeting of the American Urological Association in 2003.

Dr. Grover's clinical interests include the importance of exercise and weight reduction to reduce the risk of cardiovascular disease, diabetes, and obesity. He is happily married and has four sons.

BIOGRAPHICAL SKETCH:

Dr. Eisenberg is a tenured Professor of Medicine at McGill University and a Staff Cardiologist at the Jewish General Hospital in Montreal, Quebec. He is the Director of Clinical Research of the McGill Cardiology Fellowship Program. In addition to his clinical responsibilities, Dr. Eisenberg is the Director of the Cardiovascular Health Services Research Group of the Jewish General Hospital and a Principal Investigator at the Centre for Clinical Epidemiology and Community Studies. He has completed several studies of issues surrounding drug-eluting stents and late stent thrombosis. He has published meta-analyses of randomized clinical trials of drug-eluting stents (Lancet 2004; 364:583-91) and the effectiveness and safety of drug-eluting stents in vein grafts (Am Heart J 2010; 159:159-69), as well as a review of randomized clinical trials for prevention of in-stent restenosis (Am J Cardiol 2006; 98:375-82). He has also published studies and editorials regarding the cost-effectiveness of drug-eluting stents, including the economic impact of late stent thrombosis (Circulation 2006; 114:1745-54, Am J Cardiol 2009; 103:338-44, JACC Cardiovasc Interv 2009; 2:1188-9). Dr. Eisenberg has also recently published studies about the safety of short-term discontinuation of antiplatelet therapy in patients with drug-eluting stents (Circulation 2009; 119:1634-42) and perioperative management of patients with drug-eluting stents (JACC Cardiovasc Interv 2010; 3:131-42).

Andropause

Dr. Peter Chan is the Director of Male Reproductive Medicine at the McGill University Health Center. Dr. Chan has been involved in Andrology basic science research on epididymal sperm maturation since 1988 at McGill University. He received numerous national and international recognitions, including First Prize in Fundamental Research and the Annual Urological Research Award of the Canadian Urologic Oncology Group; Best Video at the 2002 American Society for Reproductive Medicine Annual Meeting; First prize in Audio-Visual Award at the American Urological Association Annual Meetings in 2002 and 2003; First Prize of Scientific Research Presentation from the Quebec Environmental Health Research Network in 2006 and the 2007 Clinical Diagnostic Award from the American Society of Andrology. Dr. Steven A. Grover is the founding director of the McGill Cardiovascular Improvement Program (CHIP) and the Center for the Analysis of Cost-Effective Care at the McGill University Health Center. Dr. Grover served as the Director of the Division of Clinical Epidemiology at the Montreal General Hospital from 1994-2006. Dr. Grover is also a Professor in the Departments of Medicine at McGill University. Dr. Grover was a Professor of Epidemiology and Biostatistics at McGill University from 1998 to 2009. After graduating with a medical degree from McGill University, he completed his post-graduate education at the University of California at Los Angeles (UCLA), McGill University, and Harvard Medical School. He then received his research training at the Brigham & Women's Hospital while completing a Master's of Public Administration at the Kennedy School of Government, Harvard University.

Dr. Grover's major research interest is the development and validation of computer simulation models to forecast the progression of cardiovascular disease, diabetes, and cancer. These models are used for assessing the risk and benefits of different risk factor screening strategies or therapeutic interventions. His research group has also recently completed a detailed economic analysis of cardiovascular disease which allows for cost-effectiveness analyses of risk factor reduction interventions. This work has been recognized internationally and, in 1991, Dr. Grover was awarded the Henry J. Christian Award for excellence in research at the national meeting of the American Federation for Clinical Research.

Other research interests include quality of life assessment and the economic analyses of cardiovascular disease, diabetes, obesity, HIV disease, prostate cancer and other diseases impacting on the health of men and women. He received the Prix IMS Health Canada for outstanding health economics research in 2000. Erectile dysfunction is a focus of more recent research and Dr. Grover received the Yamanouchi Impotence Best Abstract Series Award at the annual meeting of the American Urological Association in 2003.

Dr. Grover's clinical interests include the importance of exercise and weight reduction to reduce the risk of cardiovascular disease, diabetes, and obesity. He is happily married and has four sons.

Publications have been in the area of chronic pain in fibromyalgia, alternative treatments use in rheumatic diseases, and more recently evaluation of the pain experience in rheumatoid arthritis and osteoarthritis. Other research activities include evaluation of new compounds in the management of osteoarthritis, rheumatoid arthritis, psoriatic arthritis and fibromyalgia syndrome.



Dr. Schwarcz writes a weekly newspaper column in the Montreal Gazette entitled "The Right Chemistry" as well as a monthly column in Canadian Chemical News. He was the chief consultant on the Reader's Digest best sellers "Foods That Harm, Foods That Heal" and "The Healing Power of Vitamins, Minerals and Herbs" and contributed the chemistry chapter to the best-selling "Mental Floss." 
